NOVEMBER 4, THURSDAY

1.0 Call to Order – President Amy Coady

President Amy Coady called the 71st Annual General Meeting of Municipalities Newfoundland and Labrador in Corner Brook, NL to order.

1.1 Adoption of Standing Rules

2.0 Elections REPORT – MNL CEO Craig Pollett

5.0 Appointment of Auditor/Approval of Finance Report – President Amy Coady

6.0 Resolutions Session – Vice-President Trina Appleby

Vice-President Trina Appleby referred the members to the five resolutions that have been submitted for consideration by the membership. Those resolutions are contained in the conference booklet starting on page 56. Each resolution was discussed and voted on by the voting delegates; below are the results of the session.

1-2021	Be It Resolved: That Municipalities Newfoundland and Labrador request that the Government of Newfoundland and Labrador work closely with MNL to undertake a legislative review of the Municipal Elections Act. <i>(MNL Board of Directors)</i>	Carried
2-2021	Be It Resolved: That Municipalities Newfoundland and Labrador continue to work with the Government of Newfoundland and Labrador to bring into effect a standard Municipal Code of Ethical Conduct. <i>(MNL Board of Directors)</i>	Carried
3-2021	Be It Resolved that Municipalities Newfoundland and Labrador lobby the provincial government to develop provincial guidelines for the use of automated speed enforcement (AES) systems, commonly referred to as photo radar, establishing clear direction related to radar site selection, operational restrictions, data collection, and enhanced traffic safety, in an effort to address speeding in municipalities. <i>(City of Mount Pearl)</i>	Carried
4-2021	Be It Resolved: That Municipalities Newfoundland and Labrador work with the provincial government to find sector-wide solutions for childcare for elected officials while they engage in official council business. <i>(MNL Board of Directors)</i>	Carried
5-2021	Be It Resolved: That Municipalities Newfoundland and Labrador lobby the Government of Newfoundland and Labrador to mandate that all rural ambulance stations have at least one paramedic on duty at all times. <i>(Town of Cape Broyle)</i>	Carried

7.0 MNL Board Elections – Craig Pollett, CEO

Craig Pollett, MNL CEO, and Chair of the Elections, advised the members of the results of the election for board positions. There was an 82% voter turnout, 3 seats acclaimed, and 3 elections were conducted. The results are listed below.
